MAINTENANCE AND STORAGE CARE

You should follow these instructions so that your garments maintain their quality and **extend their durability**.

- Taking into account normal wear and tear, to maintain the integrity and to preserve the durability of the garment, it is necessary to take some precautions in management and use and to strictly observe the washing instructions on the inside label.
- Cotton garments tend to lose color when they are exposed to sun and light, this happens even more when the garment is worn by workers who engage in strenuous physical activities that favor perspiration.
- In the first few washes, it is natural for cotton garments to have a slight reduction in size and even a slight loss of color. Therefore, it is advisable to be very careful with washing temperatures, color separation, use of appropriate detergents, and drying.
- The zippers on clothing are tested by the manufacturers through tensile testing to ensure strength during normal use.
- Frequent use of garments, especially in the workplace, subjects the zipper to considerable stress. To ensure its durability, it must be used correctly, especially in the presence of the double slider which works on a more delicate mechanism than the single slider. By forcing the zippers, the sliding mechanisms are altered.
- This PPE may be worn in combination with other certified high-visibility garments for increased performance, provided that neither the background material nor the retroreflective material is concealed.
- **INADEQUATE USE-** attention must be paid to the dangers of improper use: **a)** the high visibility properties are only fulfilled if worn properly positioned and fastened; **b)** protective clothing does not provide the same protection if the surface of the background material and/or retroreflective material is reduced or if it is stained or damaged; **c)** thermal insulation may decrease after an inadequate washing process; **d)** thermal insulation properties are only fulfilled if worn properly positioned and fastened; **e)** this PPE does not protect against other risks, such as chemicals, heat and fire, etc.
